





PLAN NORD INITIATIVE

- Economic development strategy launched by the government of Québec in May 2011 to develop the natural resources extraction sector in the part of Québec above the 49th parallel
- The plan, to be carried out over 25 years, would foster over \$80 billion in energy, mining, and forestry investments and create or consolidate 20,000 jobs a year for the duration
- The Plan Nord affects 72% of the provinces territory and about 1.6% of its population
- The first steps in the plan was the planning, extension and construction of Route 167. in conjunction with Stornoway Diamonds, the government of Québec announced in August 2011 that Route 167 would be extended 243km to reach Québec's first diamond mine (Stornoway's Renard Diamond mine)


